Abstract: The work starts with a question: Is it possible to recognize Nature as a legal person? Although this topic has recently been studied, it has its roots in ancient natural philosophy. This work involves various fields: philosophy, law, sociology, and even health studies.

Through this lesson, I would like to reflect on the possible ways out of the constraints of anthropocentric law, starting from the analysis of some overseas legal cases, also reflecting on the forms and practices of sustainable sovereignty carried out by indigenous people in the urgency of imagine alternative paradigms to those that are the origin of the current interpretative paradigm. Then, the work will focus on theoretical and practical observations that bring together different expressions of the interdependence between human and non-human nature to address the challenges of our time, including the aspiration for On Health.
